Subject:- Issuance of Chemical Safety Certificate in favour of Carmel Convent School, Kunjwani, Jammu.

To whom it may concern

Whereas, Principal Carmel Convent School, Kunjwani, Jammu vide her application bearing ref. no. CCS/SCL/2023-2024/87 dated 29.09.2023 has applied for Chemical Safety Certificate in the office of Sub-Divisional Magistrate, Jammu South in light of J&K Board of School Education notification No. F. Cer (Gen-B) 15 KD dated 02.08.2015 in favour of the said school and accordingly this office has sought report from concerned Tehsildar, BMO and ZEO concerned.

Whereas, Tehsildar Jammu South vide letter No. TJS/OQ/2023-24/1979 dated 02.12.2023 alongwith report of the Block Medical Officer, Health and Family Welfare, Bishnah vide no. BMO/B/1010 dated 17.10.2023 and Zonal Education Officer, Purmandal, bearing no ZEO/P/2023-24/1436 dated 29.11.2023, whereby it is reported that the chemicals placed in the Laboratory used for practicals of science in above named school are kept under the proper lock and key in safe custody and under the supervision of school authorities and there is no threat for the misuse of the said chemicals.


Whereas, an affidavit bearing No. IN-JK60034176528425V dated 20.10.2023 has also been sworn by Principal of the above said school namely Sister Maria Swati A.C, whereby it has been undertaken by her that the chemicals used in the science laboratory of the above said school are kept under proper lock and key safety. Further, the Principal of the above said school also takes the responsibility of any mishappening or untoward incident or misuse of chemicals and other acidic substances.

Now, therefore, keeping in view the request of the Principal of said school, Chemical Safety Certificate is hereby issued in favour of Carmel Convent School, Kunjwani, Jammu subject to the following conditions:-

1. The school authorities shall remain fully responsible for any happening/untoward incident or misuse of chemicals and others acidic substances.
2. Safety guidelines of each and every chemical shall be followed by the said institution.
3. Material Safety Data (MSD) of every chemical shall be displayed properly.

The validity of this certificate is subject to maintenance of register of usage of acid and its monthly filing with the competent authority.
