Subject:- Issuance of Chemical Safety Certificate in favour of Carmel Convent School, Kunjwani, Bye Pass, Jammu.

Whereas, Principal Carmel Convent School, Kunjwani, Bye Pass, Jammu vide application no. CCS/SCL/2024/87 dated 25.11.2024 has applied for Chemical Safety Certificate of J&K Board of School Education notification No. F. Cer (Gen-B) 15 KD dated 02.08.2015 in favour of the said school and accordingly this office has sought report from Tehsildar Jammu South, SHO Gangyal and ZEO Purmandal.

Whereas, Tehsildar Jammu South vide letter No. TJS/OQ/2024-25/2163 dated 13.12.2024, SHO Gangyal, Jammu vide No. 66/6-1/PSG dated 09.12.2024 and Zonal Education Officer, Purmandal vide no. ZEO/P/2024-25/880 dated 26.12.2024, have communicated that the chemicals kept in the Laboratory for Science practicals in above mentioned school are kept under proper lock and key is in safe custody. There is no threat for the misuse of the said chemicals.

Whereas, an affidavit bearing No. IN-JK34406547385878W dated 28.12.2024 submitted by Principal of the above said school, wherein he has affirmed on oath that, the chemicals used in the science laboratory are kept under proper lock and key is in safe custody. Further, the Principal has also taken the responsibility of any mishappening or untoward incident or misuse of chemicals and other acidic substances.

Now, therefore, based on the report of Tehsildar Jammu South, SHO Gangyal and ZEO Purmandal, Chemical Safety Certificate is hereby issued in favour of Carmel Convent School, Kunjwani, Bye Pass, Jammu subject to the following conditions:

1. The school authorities shall remain fully responsible for any happening/untoward incident or misuse of chemicals and others acidic substances.
2. Safety guidelines of each and every chemical shall be followed by the said institution.
3. Material Safety Data (MSD) of every chemical shall be displayed properly.
4. The validity of this certificate is subject to maintenance of register of usage of acid and its monthly filing with the competent authority.
